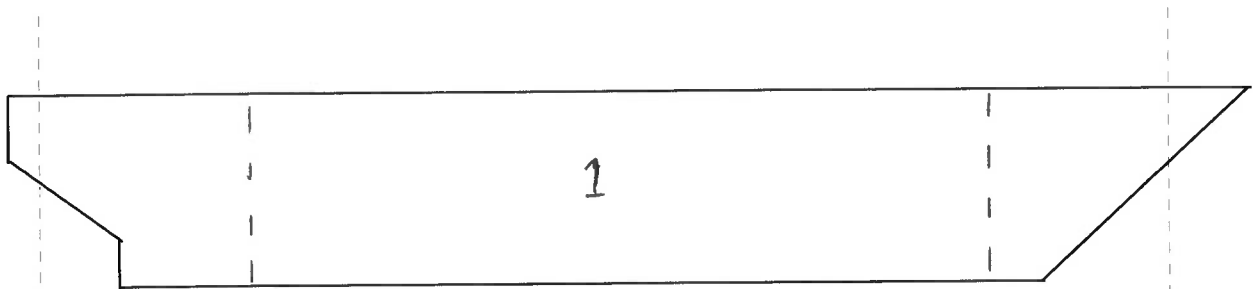

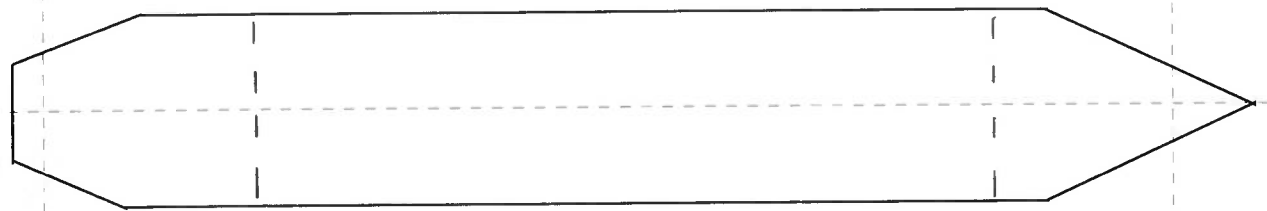

- 1) 3 mtrs. horizontally stowed away from E.R. boundaries in all cases, not stowed within a horizontal distance of 6 mtrs from any potential source of ignition and not less than 8 mtrs. horizontally stowed away from bridge, living quarters and life saving appliances.
- 2) Stowage of class 4.3 liquids having a flashpoint less than 23°C under deck is prohibited.
- 3) Isolating valve between main bilge system and hold bilgesystem to be closed and padlocked.
- 4) To be stowed at least 3 meters horizontally away from ER bulkhead.

General remarks:

- A) Cargoes required to be ventilated continuously are not allowed to be carried.
- B) Hold floodlights, entrance lights and sockets are not of a certified safe type for use in a dangerous environment. Keyswitches to be switched off and key to be removed, if required when carrying dangerous goods.
- C) FP means flashpoint
