

- Seed cake, containing vegetable oil (b) UN 1386 solvent extractions ONLY, containing not more than 10% of oil and when the amount of moisture is higher than 10%, not more than 20% of oil and moisture combined
- Seed cake with not more than 1.5% oil and not more than 11% moisture (UN2217)
- (7) Under the provision of IMDG Code, stowage of class 4.3 liquids having a flashpoint less than 23°C under deck or in enclosed ro-ro space is prohibited
