



  - protected against unauthorized re-connection
- (2) Class 8 liquids 23≤FP≤60 °C having subsidiary risk class 6.1 are prohibited
- (3) Class 8 liquids having subsidiary risk class 6.1 are prohibited
- (4) Electrical equipment which is not essential for the safety and operation of the ship and which is not of a type approved for use in the considered area shall be:
  - completely disconnected by appropriate means other than fuses at a point external to the space
  - protected against unauthorized re-connection

  - Seed cake with not more than 1.5% oil and not more than 11% moisture (UN2217)
- (7) Under the provision of IMDG Code, stowage of class 4.3 liquids having a flashpoint less than 23°C under deck or in enclosed ro-ro space is prohibited
